



MEMORANDUM OF UNDERSTANDING BETWEEN RRI VOICE OF INDONESIA AND ERASMUS HUIS JAKARTA

Today on Thursday 22 June 2023, (Twenty Two June, Two Thousand and Twenty Three) the undersigned:

Head of Voice of Indonesia, the International Service of Radio Republik Indonesia (RRI), known as **VOI-RRI**, with an address on Jalan Medan Merdeka Barat No.4-5, RT.2/RW.3, Kecamatan Gambir, Kota Jakarta Pusat, Daerah Khusus Ibukota Jakarta 10110, referred to as:

THE FIRST PARTY.

Director of Erasmus Huis Jakarta, yang berkedudukan di Jakarta, with an address on Blok C No, Setiabudi, Jl. H. R. Rasuna Said No.3, RT.8/RW.3, Kuningan Timur, Kecamatan Setiabudi, Daerah Khusus Ibukota Jakarta 12950, referred to:

THE SECOND PARTY.

In this Memorandum of Understanding, **THE FIRST PARTY** dan **THE SECOND PARTY** will be individually referred to as "**PARTY**" and collectively be referred to as "**THE PARTIES**".

THE FIRST PARTY is a Public Service Broadcasting with popular name as **Voice of Indonesia** (**VOI**) with its slogan *From Indonesia to the World*. In carrying out its activities, the **FIRST PARTY** has a target to be able to broadcast news and information to all corners of the world. For this reason, the **FIRST PARTY** can cooperate with other parties so that it can achieve its goal more effectively and efficiently.

THE SECOND PARTY is the Cultural Centre of the Netherlands in Indonesia. In carrying out its activities, **the SECOND PARTY** may cooperate with various parties to achieve its objectives: connecting the people of the Netherlands and Indonesia through arts and cultural events.





THE PARTIES agree to cooperate institutionally without interfering with the duties of each **PARTY**, to strengthen the Voice of Indonesia's International Service related to the activities of foreign agencies and representatives of foreign countries in Indonesia and disseminate information about Erasmus Huis activities to listeners abroad and in Indonesia. Matters relating to the follow-up of this Memorandum of Understanding will be regulated in a separate implementation agreement.

THE PARTIES agree to enter into a Memorandum of Understanding on the principle of partnership and provide mutual benefits for both parties with the terms and conditions as follows:

Article 1

PURPOSE AND OBJECTIVES

The aims and objectives of this Memorandum of Understanding are made by **THE PARTIES** so that each **PARTY** could carry out the programs organized by each **PARTY**. These programs, as long as this Memorandum of Understanding prevails, can be agreed upon and carried out jointly as a collaboration in order to strengthen Voice of Indonesia's programs related to the activities of foreign institutions and representatives of foreign countries in Indonesia.

Article 2 RIGHTS AND OBLIGATIONS

The Parties have the following rights and obligations:

- 1. **THE FIRST PARTY** covers and broadcasts activities organized by **the SECOND PARTY**.
- 2. **THE SECOND PARTY** gives access to information on activities in Erasmus Huis and suggests resource persons for Voice of Indonesia.
- 3. **THE SECOND PARTY** provides information and access to reporters of **the FIRST PARTY** to cover activities organized by **the SECOND PARTY**
- 4. **THE FIRST PARTY** and **THE SECOND PARTY** discuss broadcast content and materials as needed, and promote each other through respective social media.





5. **THE SECOND PARTY** provides the latest information and/or news in Dutch language in text form in connection to its activities in the venue to enrich Dutch Program on Voice of Indonesia.

ARTICLE 3 FINANCING

THE PARTIES agree that based on this Memorandum of Understanding will not burden each other for the costs that may arise in the programs of each **PARTY**, unless there is a mutual agreement on a particular financing as long as it is mutually agreed upon by **the PARTIES**.

ARTICLE 4 TERM

- (1) This Memorandum of Understanding shall commence upon the Effective Date, as stated above, and will continue until 31 December 2024. This Memorandum of Understanding can only be extended or terminated with written evidence.
- (2) In the event that one of **the PARTIES** intends to terminate this Memorandum of Understanding before the period stated in paragraph (1) of this article, **the PARTY** concerned must notify the other **PARTY** in writing, received no later than 1 (one) month prior to the term of the Memorandum of Understanding ends.
- (3) This Memorandum of Understanding can terminate or cancel automatically if:
 - a. In the future there are statutory provisions that specifically regulate and conflict with the scope of this Memorandum of Understanding.
 - b. The objectives of **the PARTIES** have not been achieved in accordance with the provisions of Article 1 above.

ARTICLE 5 DISPUTE RESOLUTION

Should any differences or misunderstandings arise in the implementation of this Memorandum of Understanding, **THE PARTIES** agree to resolve them by deliberation and consensus.





ARTICLE 6 CLOSING

- (1) Matters that have not been regulated in this Memorandum of Understanding, will be regulated later in the form of an Addendum to the agreement of **THE PARTIES** and is an integral part of this Memorandum of Understanding.
- (2) This Memorandum of Understanding is carried out institutionally by respecting and heeding the rules and regulations that apply in each institution.
- (3) This Memorandum of Understanding is drawn up in 2 (two) copies as needed and each is affixed with sufficient stamp duty, has the same legal force, each for **the PARTIES**.
